Commitment of Time, Conflict of Interest, Consulting and Other Employment  
Consulting Request Form (four forms)

**Rationale:** the Conflict of Interest arrangements have been criticized in the Senate.

**Governance**

Faculty Code of Rights, Responsibilities and Conduct  
Under 'Approved by: Chancellor', add 'and by the Faculty Senate'.

**Rationale:** this was recognized to be a shared governance document during discussions in the Faculty Senate when it passed the Code.

Procedures for Appeals to the Faculty Rights Board for Tenure and Promotion Decisions  
Procedures of the Faculty Rights Board for Hearing Appeals from Administrative  
Actions

**Rationale:** the Faculty Rights Board has made representations to the Senate requesting some revision in this area.

Student Senate Rules & Regulations

**Add** that this was approved by the Student Senate, and the date on which it gave its approval. **Check** with Student Senate leaders that the text is accurately displayed.

**Rationale:** the Student Senate President complained to Sen Ex last semester that the text displayed in the Policy Library was different from the one passed by the Student Senate.

Add by which administrator this was approved.

**Rationale:** The omission seems to be a clerical error.

**Instruction**

University Academic Assessment Committee Member Selection

**Rationale:** should members of committees be appointed by the Provost's Office, or elected by Governance?

Intellectual Property Policy for the Lawrence Campus

**Rationale:** this has been criticized in the Senate.
